Motion made by Cannon second by Shelton to approve the previous minutes. Vote: Aldermen Shelton, Cannon, Green yes Mayor Higdon pass.

Motion made by Higdon second by Shelton to approve payment to Mike's Electrical service for repairs completed in the fire department. All present voted yes.

Motion made by Shelton second by Cannon to approve the library participating in a summer reading program and to use the meeting room for lunch to be provided to the participants for the following dates June 13- July -18. All present voted yes.

Motion made by Cannon second by Green to approve the Librarian attending workshops on the following dates: April 24 and May 8 . All present voted yes.

Reports were submitted from the Fire, Police, Street and Library Departments.

Motion made by Shelton second by Cannon to table the uniform rental contract until the next meeting. All present voted yes.

Motion made by Cannon second by Shelton to charge a \$10.00 monthly sanitation pick up fee for Town House Gallery. All present voted yes.

Mr. John Ball with Birch telecom presented a quote for telephone service.
