Motion made by Burrell second by Green to approve installing a streetlight on Green Hill Lane and one at 447 Eagle Bluff Road. All present voted yes.

Motion made by Forstner second by Green to approve the brochure stating the services that are provided by the Town. All present voted yes.

Motion made by Green second by Cannon to request the CJUC to assist the street department with flooding problems at the creek on Cedar Lane. All present voted ves.
