**Motion made by Forstner second by Burden to approve the previous minutes. All present voted yes.**

**Reports from all departments were submitted for review.**

**Motion made by Forstner second by Burden to approve the request from the street department to purchase tile to be installed on Water Street and Liberty Street and a part for the garbage truck. All present voted yes.**

**Motion made by Burden second by Forstner to approve request from the Fire Department to purchase truck parts at the cost of \$359.85, a GPS unit for hydrant location cost of \$120.00, 3 classroom tables cost of \$240.00. All present voted yes.**

**Motion made by Forstner second by Green to approve the Police Department request to purchase (3) safety vest 50% of cost to be funded from grant funds and repair vehicle damaged in accident (estimates were received). All present voted yes. Alderman Burden stated his conflict of interest concerning the repair estimate of patrol car as Jacksboro Body Shop was the lowest estimate received.**

**Motion made by Forstner second by Burden to approve subdivision regulations submitted and approved by the Jacksboro Planning Commission. All present voted yes.**

**Motion made by Forstner second by Green to approve the first reading of Ordinance #93-Municipal Flood Damage Prevention Ordinance. All present voted yes.**

**Motion made by Forstner second by Green to table Resolution #291 until the next regular meeting. All present voted yes.**

**Motion made by Forstner second by Burden to approve the bid received for the early warning system received from Sentry Siren, Inc. in the amount of \$10,300.00 and to approve Overbay Communications to install the system at the cost of \$1200.00 All present voted yes.**

**Motion made by Burden second by Forstner to approve two fire department and two street department employees attending a chemical response training class on April 25<sup>th</sup>. All present voted yes.**

**Motion made by Forstner second by Burden to approve purchasing city court dockets, as needed. All present voted yes.**

**Motion made by Burden second by Forstner to approve fire, police and street department heads attending the NIMS training class in Knoxville on April 18<sup>th</sup>. All present voted yes.**

**Motion made by Forstner second by Burden to approve expenditures and financial report. All present voted yes.**
