

**Board of Mayor and Aldermen Meeting  
November 4, 2010**

**The Board of Mayor and Aldermen met in regular session on Thursday, November 4, 2010 at 7:00 P.M.**

**Present: Aldermen Nance, Burden, Forstner, Green and Mayor Cannon.**

**Motion made by Forstner second by Green to approve previous minutes. All present voted yes.**

**Motion made by Forstner second by Burden to approve the Librarian attending a workshop on November 19, 2010. All present voted yes.**

**Mayor Cannon presented a proposal to council for employee Christmas Bonus. Full time employees' \$400.00 plus longevity pay of \$25.00 per year. Part time employees to receive \$25.00 to \$100.00 depending on actual hours worked.**

**Motion made by Forstner second by Nance to approve the employee Christmas bonus package, as presented. All present voted yes.**

**Motion made by Forstner second by Burden to approve list of items to be auctioned on 11-16-10 and to include the following items: cameras, radio equipment, books and videos, two vehicles, confiscated weapons and miscellaneous evidence confiscated by the Jacksboro Police Department as listed in Exhibits A and B as approved by the Criminal Court of Campbell County. The Mayor or Police Chief is authorized to remove any item from list, if needed. All present voted yes.**

**Motion made by Green second by Forstner to request the Campbell County Election Commission to hold a city election on the first Saturday of April, 2011 from 9:00 A.M. to 7:00 P.M. to elect two (2) Aldermen each for a four (4) year term. All present voted yes.**

**Motion made by Burden second by Nance to approve the street department purchasing a leaf blower at the cost of \$259.95 and a tire for the recycling truck. All present voted yes.**

**Following a discussion of the energy weapons (taser) policy, motion made by Forstner second by Burden to approve the policy as written with the change to the first offense violation to include up to a maximum of fourteen (14) days suspension without pay or termination pending upon investigation. Vote: Aldermen Nance, Burden, Forstner, Mayor Cannon- yes. Alderman Green-no.**

**Motion made by Forstner second by Burden to advertise for bid to purchase seven (7) tasers for the police department. Vote: Aldermen Nance, Burden, Forstner, Mayor Cannon – yes. Alderman Green – no.**

**Motion made by Forstner second by Green to approve purchasing a light bar for the animal control vehicle. Cost of \$109.99. All present voted yes.**

**Motion made by Forstner second by Green to approve expenditures and financial report. All present voted yes.**

**Motion made by Forstner to adjourn.**
