

**Board of Mayor and Aldermen
Regular Monthly Meeting
May 3, 2012**

The Board of Mayor and Aldermen met in regular session on Thursday, May 3, 2012 at 7:00 P.M.

Present: Aldermen Nance, Burden, Forstner, Green and Mayor Cannon.

Motion made by Burden second by Forstner to approve previous minutes. All present voted yes.

Mayor Cannon reported to Council the Recreation Grant contract ends on September 30, 2012 and that the park pavilion, sidewalks and equipment can be purchased through a Federal Contract which would eliminate the bid process.

Motion made by Forstner second by Burden to complete the park project using vendors through the Federal Contract. All present voted yes.

Motion made by Forstner second by Green to approve an audit contract with Mitchell, Emert and Hill, CPA in the amount of \$8725. All present voted yes.

Motion made by Forstner second by Green to approve a request from the Campbell County Sheriff Robbie Goins for \$3000.00 to help fund the cost of purchasing a new communications/radio repeater. All present voted yes.

Motion made by Forstner second by Green to approve LaFollette Tree Trimming to remove a tree located on Valley Street at the cost of \$425. All present voted yes.

Motion made by Forstner second Burden to approve purchasing two (2) front tires for the recycling truck at the cost of \$135.00 each (from White Tires-lowest quote) and to purchase parts needed to repair the recycling truck including Bowlin Auto completing some of the repair work; cost of parts \$602.79 All present voted yes.

Quotes were received to paint the 1997 Ford street department truck.

Kitts Paint & Body Shop in the amount of \$2595.00

Motion made by Forstner second by Green to approve the quote from Kitts Paint & Body Shop in the amount of \$2595.00 All present voted yes.

Motion made by Forstner second by Burden to approve purchasing equipment for the 2012 patrol car (radar, siren, etc.) approximate cost of \$5000.00 All present voted yes.

Motion made by Burden second by Nance to approve repairing cameras in two of the patrol vehicles and repairing the air conditioning in one unit. All present voted yes.

Motion made by Green second by Forstner to approve disposing of three of the street department lawnmowers at the public auction to be held on 5-5-12. All present voted yes.

Motion made by Forstner second by Burden to approve the street/sanitation department changing their work schedule from 7:00 AM to 3:00 PM to 6:00 AM to 2:00 PM to be effective May 14, 2012 to September 30, 2012. All present voted yes.

Motion made by Forstner second by Green to approve expenditures and the financial report. All present voted yes.
